1 General

- 1.1 This production process specifies a description of the shape, content, linear dimensions, color design and the procedure for applying the mark of conformity of the Halal product confirmation of conformity body (hereinafter Halal CCB) in the Republican State Enterprise on the right of economic management "Kazakhstan Institute of Standardization and Metrology" (hereinafter KazStandard).
- 1.2 The requirements of this process are mandatory for all personnel of the Halal CCB.
- 1.3 This process is an internal regulatory document of KazStandard and is not subject to presentation to other parties, except for experts appraisers of the accreditation body, when assessing by the CCB, auditors of certification bodies when conducting audits of the management system (QMS), as well as consumer partners (at their request) with the permission of the General Director of KazStandard.

3 Terms and definitions

3.1 The following terms and definitions apply in this process.

Halal conformity mark is a designation, serving for information to the buyers that the products passed the procedures for conformity confirmation with the requirements, specified by the documents for Halal products.

Halal products are products, that are allowed to be used and consumed in accordance with the religious traditions of Islam.

4 Designations and abbreviations

4.1 The following designations and abbreviations apply in this process:

KazStandard The Republican State enterprise with the right of economic

Quality management system;

Halal CCB

Halal Conformity Confirmation Body

5 General

5.1 A decision to provide marking with a conformity mark is made for products for which a certificate of conformity has been issued as part of Halal CCB accreditation in accordance with the requirements of GSO 2055: 1.

The procedure for marking with the conformity mark is carried out in accordance with the requirements of this document.

To obtain the right to mark products with the Conformity Mark, the applicant, simultaneously with filing an application for the confirmation of conformity, shall apply for the right to mark the products with the conformity mark. With a positive certification, Halal CCB concludes a certification contract with the applicant, which provides the use of a conformity mark.

6 Shape, size and technical requirements

6.1 The conformity mark for products certified in accordance with the requirements of Halal CCB must have a graphic image in accordance with Annex A.

6.2 The graphic representation of the Mark of Conformity should be accompanied by the number of the Certificate of Conformity. The dimensions for drawing the mark

must correspond to the dimensions, specified in Annex B.

6.3 The designation of the number of the certificate of conformity is applied at a distance of 0.2N under the graphic image of the Mark of conformity, in accordance with Annex B, symmetrically about the B axis in font Straight3 in accordance with GOST 26.020. The font size is selected from the range 1.0; 1.2; 1.6; 2.0; 2.5; 3.0; 4.0; 5.0; 6.0; 8.0; 10.0 mm.

6.4 The size of the Mark of conformity is determined by the enterprise (organization) that has received the right to use it, by choosing the base size N. The base size must be at least 10 mm. The size of the Mark of conformity must ensure the clarity of its elements and their visibility to the naked eye against the general colored background of the object.

6.5 The conformity mark must be in a prominent location, bright and indelible. The

color of the Mark of conformity must offer a contrast to a background color.

6.6 The image of the product conformity mark must be monochromatic and offer a contrast to the surface color on which it is applied. The Mark of Conformity must be green (RGB: R0 G102 B51).

6.7 The conformity mark can be made in any way that ensures its legible and clear

image throughout the entire service life of the product.

7 Halal products marking procedure

7.1 Manufacturers (suppliers) of products have the right to mark them with the conformity mark if the products have passed all the established procedures for conformity confirmation with the requirements of GSO 2055: 1.

7.2 The conformity mark is applied to each product unit, packaging or

accompanying documentation.

7.3 The application of the conformity mark on products, manufactured in accordance with GSO 2055: 1, is carried out by the applicant (manufacturer, seller, performer). Standards and other standardization documents, compliance with the requirements of which is certified by the Mark of conformity, are indicated in the certificate of conformity, based on which this Mark of conformity is applied.

7.4 Production of Halal products marking goals:

assistance in increasing confidence in the manufacturer (seller, performer), as well as in the sale of manufactured and released Halal products;

 assisting consumers in obtaining necessary confidence in the safety of the production of Halal products for the life and health of people, property of citizens and the environment;

creation of the necessary conditions for the activities of legal entities and

individuals in the commodity market of the Republic of Kazakhstan

7.5 The Halal mark of conformity is applied to each product unit, package next to the manufacturer's trademark (if any) or above the designation of a standardization document against which requirements Halal products are certified. If it is impossible to apply the Mark of conformity directly to products it is applied to containers or packaging. Operational, technical and shipping documents must also be marked with the Mark of conformity in the location where information is provided on the confirmation of conformity of Halal products (number and date of issue of the certificate of conformity, name of the organization that issued the certificate). Having such information, the production of Halal products and Halal products marked with the Mark of conformity need not be accompanied by copies of the Certificate of conformity. The use of the Mark of Conformity is also considered to be its use in advertising, printed publications, when demonstrating exhibits at exhibitions and fairs associated with reference to the right to mark products with the Mark of Conformity.

7.6 If the Mark of conformity is applied to packaging materials, then the storage and use of the labeled packaging materials must be carried out in a manner that excludes the possibility of their use GSO 2055: 1 for products that have not passed certification.

7.7 Monitoring compliance with the conditions for labeling Halal products is

carried out during inspection control of certified Halal products.

7.8 Suspension of validity or cancellation of the certificate of conformity of Halal products entails, respectively, suspension or termination of the right to use the Mark of conformity.

7.9 The applicant is responsible for the quality of the certified products and the

correct application of the Mark of conformity.

8 Requirements for the supervision, control and branding of slaughtered animals

8.1 Halal certificate must be attached to each batch of meat or meat products, provided that the certificate is issued by Halal CCB, accredited to comply with the requirements of GSO 2055: 2.

8.2 The certificate shall state that slaughtering and production were carried out

in accordance with the conditions of the GSO standard.

8.3 Meat and meat products must have the brand mark (seal) of the Halal CCB that issued the certificate. The Halal CCB brand must be protected from counterfeiting, the paint for branding must be resistant and safe for health. Each carcass (chilled or frozen) or finally packaged individual meat cuts must be marked with the official Halal CCB hallmark or certified organization.

9 Labeling

- 9.1 In accordance with the requirements of the GSO-9 standard, the label must contain the following information (insert card) about animals, including the following:
 - Name of the manufacturer and type of animal;
 - Date (day, month and year) of slaughter;
 - Date of manufacture;
 - Veterinary certificate number with information about the animal;
 - Indicate if an automatic slaughtering machine was used;
 - Indicate if electric stunning was used.
